## Details Pertaining to the Borden-McClendon Scholarship

The Borden-McClendon Scholarship is the name of the scholarship that will be given each year by the Arkansas Assessor's Association at the Summer Meeting. The following will address the "specs" of this scholarship.

1. Who is eligible?

The child, step child, adopted child, grand-child, great grand-child, great great-grand child or employee of an assessor's office in the State of Arkansas.

2. What schools are eligible?

Anyone going to college is eligible no matter what state the college they are attending is located in. Students attending two year colleges are also eligible for this scholarship. Students attending trade schools and service academies are also eligible.

3. How is the applicant chosen?

The applicant will be chosen by a group of 4 Assessor's. This group will be chosen each year at the Assessor's Summer Meeting by the scholarship director. Any tie will be broken by the scholarship director.

4. When will the "selection committee" meet?

The "selection committee" will meet on Wednesday morning at the Assessor's Summer Meeting before the roll call at this meeting.

5. When will the scholarship be presented?

The scholarship will be presented at the Assessor's Summer Meeting each year in proxy. If the person that receives the scholarship cannot be present, then the scholarship will be presented to the assessor of the county that the scholarship winner resides. If the assessor is not present then a letter will be mailed to the recipient, notifying them that they were selected for the scholarship. The actual check (\$1,000.00) will be mailed to the university or secondary educational school that the recipient has chosen to attend.

6. How will the recipient of the scholarship be chosen?

The recipient of the scholarship will be chosen by the “selection committee” which consists of 4 members. The “selection committee” will look at the transcripts and character references that will be provided in the application of the applicant. The decision of who receives the scholarship will be the sole responsibility of the “selection committee”. Only one person will be chosen by the selection committee.

7. When will the applications for the scholarship be available?

The applications for the Borden-McClendon Scholarship will be mailed or e-mailed to each assessor’s office between January 1<sup>st</sup> and April 15<sup>th</sup> of each year.
